# Geauga County General Health District Board of Health Meeting Minutes November 16, 2015, 7:00 p.m. Geauga County Health District Office 470 Center Street, Bldg. 8, Chardon, OH 44024

#### Call to Order

Mr. Goergen, President, called the monthly meeting of the Geauga County Board of Health to order at 7:00 p.m.

## II. Pledge of Allegiance

Mr. Goergen asked everyone to stand and recite the Pledge of Allegiance.

# III. Presentation to Betty Benenati

Mr. Goergen thanked the Benenati family for coming to the meeting. He stated that Mr. Benenati had done tremendous work for the residents of Geauga County and the Geauga County Board of Health will be indebted to him as past President and for all of the special projects he was involved in as a Board member. Mr. Weisdack read Resolution 2015-5 honoring J. David Benenati to the audience.

#### VIII. Environmental Health Program Update

#### a. Sewage Rules

Mr. Weisdack and Mr. Goergen explained some sewage history for a Kent State student that was in the audience. This included the For Sale of Property program and the new sewage rules and how it affects the residents.

Mr. Weisdack reviewed the number and types of permits that have been issued so far this year with the Board. He stated that he is concerned with the number of permit issued for NPDES systems.

Mr. Weisdack plans to meet with some of the other health commissioners in December to continue the discussion of the new sewage rules.

# IX. Personal Health Services Update

#### a. Public Health Emergency Preparedness

The staff continues to meet with regional and local partners to develop a local Ebola response plan and local Functional Needs plan. They have also attended the regional public health meeting, regional EPI meeting and Biowatch Advisory Committee meeting in October.

# b. Disease Surveillance

The disease count for October was 38, 18 of which were STD's. Some cases which were out of the ordinary included Mumps, Ecoli and Hep A.

Jay Becker attended a Bed Bug Conference in Cleveland, which resulted in a need to develop standard operating guidelines to handle future inquiries from residents.

#### c. Nursing Services

During the month of October, the nursing staff provided two Amish Well Child Clinics, 6 children and adolescent immunization clinics, 4 Friday Morning Adult clinics, and 3 Senior Center clinics. Included were visits for 22 children at the well child clinics, 524 vaccinations given to 189 children, 59 adult immunizations, 87 BP and 29 TB tests. The nurses also provided vision screenings that resulted in referrals for glasses for 19 children. There were 5 maternal/ newborn visits and 2 BCMH home visits.

Our nursing director participated in the RN peer review and held the annual school and public health consortium, which includes our staff nurses and nurses from the local school districts.

The Board expressed their concern that our nursing services are still covering patients for Lake County Health District. They asked Mr. Weisdack and Mr. Mix to calculate those costs so they can be reviewed. They would like the information available for the next meeting.

## d. WIC

The WIC caseload for October was 714.

Geauga WIC attended the TriCounty Breastfeeding Conference and the Lake County Breastfeeding Conference in October.

The contract peer helper has cut her hours to care for her infant child. The staff is considering contrating with another peer helper to fill the 60 hour per month void.

#### e. Administration

The Board was asked to approve three requests to the Geauga County Auditor to create new expense line items, create a new fund for the Ohio EPA Water Pollution Control Fund, and to create a new fund for the For Sale of Property Program.

The Board was asked to approve a revision to the Geauga County Health District Personnel Policy Manual to clarify who is an exempt employee and to increase scheduling flexibility of an exempt employee.

#### f. Accreditation

The Performance Management and Quality Improvement Committee completed the PMQI plan for the department. The plan links to the agency strategic plan which calls for an implementation date of 2016. Staff will need training and the monthly reporting of the EH and PHS statistics altered to include the performance measures identified in the plan.

The Ohio Department of Health is now accredited. There are 8 local health districts who have completed accreditation. Ohio has the most accredited health departments in the United States.

#### X. Old Business

#### a. OEPA Water Pollution Control Fund

Mr. Weisdack showed the Board the guide for the new fund. It shows that the Geauga County Health District has been awarded \$300,000.00 to assist the residents with replacing malfunctioning septic systems. The implementation date is set as January 6, 2016. We have never received an official award letter from OEPA.

Community Development has agreed to assist us through this process.

We recently found that the Ohio Department of Agriculture has a program to assist residents as well.

#### b. General Information

There were no other topics discussed.
