b. Colin Cooper

Mr. Shubick stated that this is a variance request by Colin Cooper/Horizon Excavating for the property located at 11420 Frostwood Dr., Auburn Twp. The request involves section 3701-29-06(G)(3)(b) of the Household Sewage Treatment System Regulations which requires fifty feet (50) of horizontal isolation from a wetland.

Section 3701-29-06(G)(3)(b) states: "A sewage treatment system soil absorption component shall be at least fifty feet from any surface water impoundment, lake, river, wetland, perennial stream and road cut-banks or stream cut-banks."

Mrs. Livers moved to approve the variance as requested. Mr. Gragg seconded the motion. Motion carried with a roll call vote. Mr. Goergen, yes; Mrs. Livers, yes; Mr. Gragg, yes; Mrs. Whitright, yes; and Dr. Wynbrandt, yes.

VIII. Administrative Hearings

a. John & Stephanie Sutter/Ramble Inn/Bill Prots/Mill Enterprises

Section 52.05.02: "APPLICATION – Any person, firm, association, or corporation who, subsequent to the first day of September of that year, has intent of operating a semi-public sewage disposal system must obtain an inspection certificate from the Geauga County Health Department."

Section 52.05.04: "CERTIFICATE ISSUANCE – Certificate renewal forms will be mailed the last week of July. Owners of the property are responsible for returning the completed form and proper payment to the Geauga County Health Department by the filing deadline of September 1 of that year. All applications post marked later than the September 1 date shall be regarded as late and be subject to a 25% late fee. The fee schedule shall be adopted by the Geauga County Board of Health." Discussion followed.

b. Marlene Lindgren and Phillip Sindelar & Michelle May

3701-29-25(A) "An evaluation of a residential sewage system must be completed at time of transfer of ownership of any parcel with said system. The evaluation shall be conducted by a member of the Health District and if necessary any corrective actions(s) required shall be accomplished within the time period(s) directed."

Mr. Kovach stated that he did not know an inspection was needed of the septic when he purchased the home. His realtor did not inform him of the regulation. He stated that he would have to destroy his yard to put in a sample well and that it cost too much money to do it. More discussion followed. Mr. Kovach was instructed to contact Mr. Shubick to review the site and decide what was needed at his property.

Mr. Wolcott continues to make progress at his site. He recently made another payment toward his fine.

- VIII. Personal Health Services Update
 - a. Public Health Emergency Preparedness

Mrs. Andrews reported that Robyn Bull has successfully completed the FEMA Emergency Operation Center Course. This will enable her to be a backup for Tammy Spencer.

The staff attended multiple different workgroups this past month and represented the Health District at the Geauga County Local Emergency Planning Committee.

The current PHEP grant concludes June 30, 2017. The staff continues to work on grant deliverables. We received notice of award for the 2017-2018 grant which will begin July 1, 2017.

b. Disease Surveillance

There were 34 Investigations for April. Forty-one percent were STDs.

Ms. Spencer & Mrs. Bull attended a Hepatitis C workshop in Columbus recently.

c. Nursing Services

Mrs. Andrews stated that the Health District successfully completed the Vaccine for Children onsite review.

The New IAP grant began April 1, 2017. Work on the grant deliverables continue. The staff is working to assure that the needs of the community are met while being fiscally responsible.

d. Accreditation

The Accreditation Team has been assembled and is progressing through the work plan.

IX. Old Business

a. Mansour-Gavin Contract Increase
