VII. Environmental Health Program Update

a. OEPA Water Pollution Control Loan Fund

Mr. Weisdack reported that the Health District has been approved for funding through the grant for 2017 for \$300.000.00.

b. OEPA Mosquito Grant

Mr. Shubick reported that he is working toward applying for the grant for 2017. Under the 2016 grant, there have been seven scrap tire sites cleaned up. This effort collected and disposed of more than 2,500 tires.

Mr. Shubick praised the MRC on their superb job of presenting information to county residents and agencies about home mosquito control. They also provided mosquito dunks to residents.

VIII. Personal Health Services Update

a. Public Health Emergency Preparedness

Mrs. Andrews stated the staff attended the NE Ohio Regional Epi & Public Health Meeting, Zika tabletop meeting as well as the Geauga County Local Emergency Planning Committee meeting.

The staff met with the Lake County Health District Director of Community Health Services to learn about PHEP grant utilization and budget items.

b. Disease Surveillance

For February, there were 36 cases of communicable diseases. This included 14 that were STDs and five people hospitalized for flu.

c. Nursing Services

Mrs. Andrews stated the nurses finalizing vision screenings for Amish schools. The screenings must be completed by April.

The Children and Adolescent Immunization clinic moved to the Methodist Church. The church staff is very welcoming and accommodating and the space is very nice. This location is also where the Cleveland Food Bank places their excess food supplies for residents to take.

We have been awarded a new program, which will provide vaccine for adults. This is very similar to our vaccine for children program.

d. WIC

Geauga WIC has been transferred to Lake County. The WIC staff are still working from our offices, but will be moving to space in Huntsburg very soon.

e. Accreditation

Our Accreditation Coordinator has been working on several community surveys. She met with Ron Graham from the Lake County General Health District to assist her with getting started with her new position.

IX. Old Business

a. 2018 Geauga County General Health District Preliminary Budget

Mr. Weisdack asked the Board to table the approval of the budget. He has been unable to complete it due to several issues within the department. The Board agreed and set a meeting for Friday, March 24, 2017 at 3:00 p.m. in the health district office.

b. Website Design-Julie Stout, ADVANdesign

Ms. Stout presented several ideas for a logo and a graphics for the vehicles. She provided a draft of the website design for the Board to review.

The Board suggested some changes to the website and discussed the different logos and graphic designs. Overall, the Board was pleased with everything submitted.

c. Ron Graham & Adam Litke, Lake County General Health District

Peggy Herman asked how the department was running and if the accreditation and grant requirements were being met. Mr. Goergen stated that the Board was confident that the Health District would meet the 2020 deadline. She also asked if regionalization was a possibility due to the WIC partnership with Lake County General Health District.

Mr. Graham stated that LCGHD was working with the Geauga County Health District to get through the accreditation process as well assisting with the transition for WIC. This will better serve both counties' residents. He stated that it is not the position of LCGHD to take over the Geauga County Health District.

Mr. Graham reported that WIC would be moving to the new Huntsburg location in April.
